The Public Hearing will be held at 6:00 p.m. on the second Tuesday of every month at the Shawnee County Annex, 1515 NW Saline Street, First Floor Conference Room. The Planning Commission conducts an informational meeting with staff that is open to the public at 5:00 p.m. on the same date in the Planning office prior to the public hearing.

In conjunction with the Preliminary Plat Phase, a Final Plat may only be filed with prior approval by the Planning Director.
