

RESOLUTION

Upon motion made, seconded and unanimously passed, the following resolution was adopted:

WHEREAS, the township is charged with maintenance and jurisdiction over certain Township roads and right-of-ways and needs to make a timely review of the permit applications for the installation of drainage tubes and drainage pipes along the right-of-way of the Township roads; and

WHEREAS, Tecumseh Township meets only once a month and hereby seeks to establish a procedure for the review of permit applications for the installation of drainage tubes and drainage pipes along the right-of-way of the Township roads as well as the installation and inspection of the same,

NOW THEREFORE, be it resolved by the Governing Board of Tecumseh Township, Shawnee County, Kansas, that it hereby delegates authority to the Township's Road Foreman to perform any and all review of the permit applications and to establish the proper procedures for the installation of any drainage tube or drainage pipes within the Township, and to accept, modify or reject any permit applications made to the Township;

IT IS FURTHER RESOLVED that the Township Road Foreman shall have the authority to perform any inspections on behalf of the Township of any drainage tubes or drainage pipes within the Township, shall have the authority to determine whether the installation of the drainage tubes or drainage pipes meet with the proper procedures for and standards for installation (based upon the Shawnee County specifications for right-of-way use permits) and shall have the authority to order that the same be corrected at the expense of the owner;

IT IS FURTHER RESOLVED that the Township Road Foreman may at his discretion authorize other employees of the Township Road Department to act on his behalf, and to perform any of the above duties designated to the Road Foreman.

This resolution shall continue in effect until revoked or modified by the Township Board.

This resolution shall continue in effect until revoked or modified by the Township Board.
