THIS AGREEMENT, made and entered into, by and between the Topeka Township, hereinafter, referred to as the "Township" and _____

WHEREAS, the Township has jurisdiction over right-of-ways on designated roadways within Topeka Township, Shawnee County, Kansas, and

WHEREAS, the Township believes it is in the interest of the citizens of the Topeka Township to permit certain work or projects to be performed upon road right-of-ways, and

WHEREAS, the Petitioner requests permission and authority from the Township to perform certain work, described as follows:

Must have a minimum of 4" dirt cover over pipe and minimum of 4" crushed rock (compacted AB-3) cover over drive from edge of road to property line. Installation shall be in accordance with Township Resolution No. 2010-07-13-02, dated July 13, 2010. Before any work shall be done, the proposed project must be approved as directed by the Township. All work shall be performed by the Township with the owner to pay in advance the cost of the tube and installation fees as established by the Township after inspection (a minimum fee of \$1,300.00 shall be applicable). Any work not performed by the Township, which fails to meet with the standards set forth by the Township shall be corrected at the expense of the property owner. Driveways shall be installed "flush" with all existing roadways in such a manner to prevent potential damage from snow removal operations. In no case shall three-foot approach of the drive at the road surface edge be constructed to an elevation higher than the edge of existing road surface. The top of the culvert pipe shall be below the surface of the existing road.
